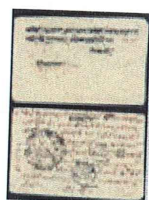
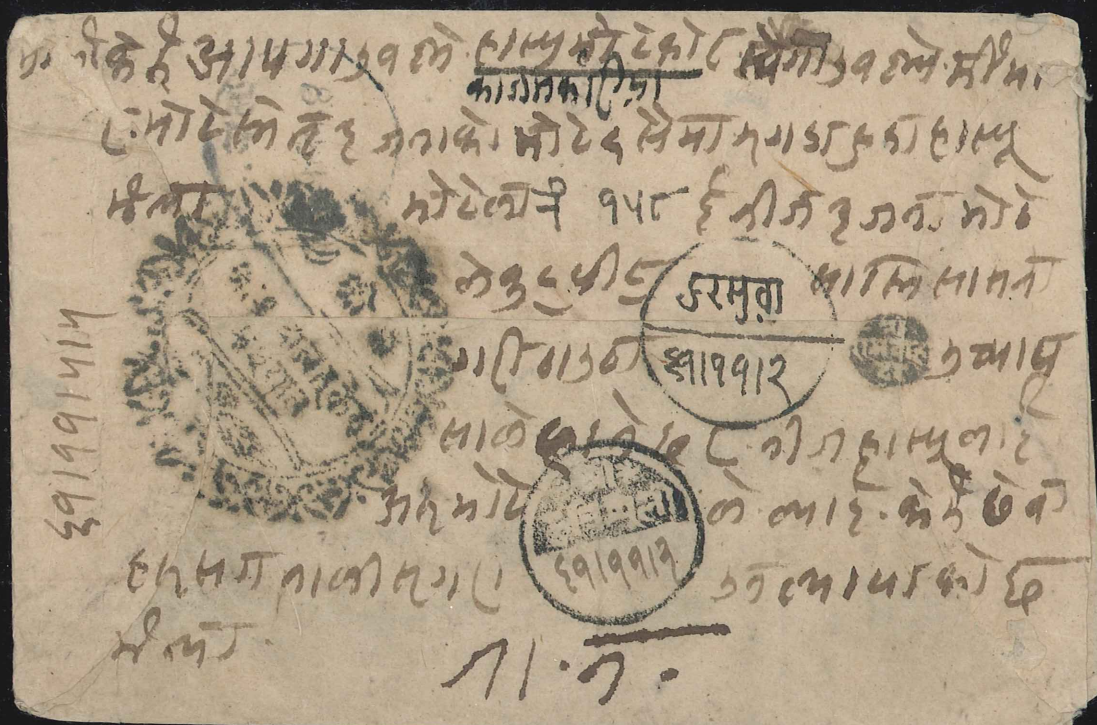
1905 Stampless Cover from Kuti, Tibet to Kathmandu, Nepal. The cover was sent to the Comander in Chief of the Nepalese Army, Bhim Shumsher Jung Bahadur at Tangal Palace. It bears the KUTI COURT SEAL cancel, with handwritten TATAPANI (dtd BS 62.8.11 = 1905) with Nepalese Negative transit mark of HOTARA (dtd BS 62.8.11) and KATHMANDU Arrival in Manuscript (dtd BS 62.8.14). (By the treaty of Thapatail in 1854 a Nepalese Residency was established in Lhasa and eventually Nepalese jurisdictional courts were established in Khasa, Kerong & Kuti. Established not only for the purpose of holding trials for Nepalese merchants and traders who had committed crimes in Tibet, but also to see that they received the fair and just treatment not given them by Tibetan courts. As a result, Nepalese merchants were allowed to reside and trade freely in Tibet.)



ca. 1900: REGISTERED STAMPLESS COVER.

KERONG to KATHMANDU. Carried by runner from KERONG to KATHMANDU, bears KERONG COURT SEAL, Nepalese ms. post mark, and Negative Transit Mark, plus a KATHMANDU Receiving hs.. (see China Clipper #240 1979)

1904 Stampless Cover from Kerong, Tibet to Kathmanu, Nepal. (The actual return address is a village called "Up" in Kerong District. It bears the KERONG COURT SEAL cancel, Nepalese ms. post mark of RASUWA (dtd BS 61.11.2 = 1904) and Negative transit of TRISULI (dtd 61.11.3). The notes on the cover mention that at the time of a Tibetan festival, three Tibetan men attacked another Tibetan, stabbing though not killing him – but a case had been filed in the Kerong Court. The Nepalese Courts in Tibet were primarily for the benefit of Nepalese, but Tibetan could also seek justice with these courts. (By the treaty of Thapatal in 1854 a Nepalese Residency was established in Lhasa and eventually Nepalese jurisdictional courts were established in Khasa, Kerong & Kuti. Established not only for the purpose of holding trials for Nepalese merchants and traders who had committed crimes in Tibet, but also to see that they received the fair and just treatment not given them by Tibetan courts. As a result, Nepalese merchants were allowed to reside and trade freely in Tibet.)

The "Official" stamps are extensively forged, but this stamp is guaranteed to be a genuine copy of Scott #02)*

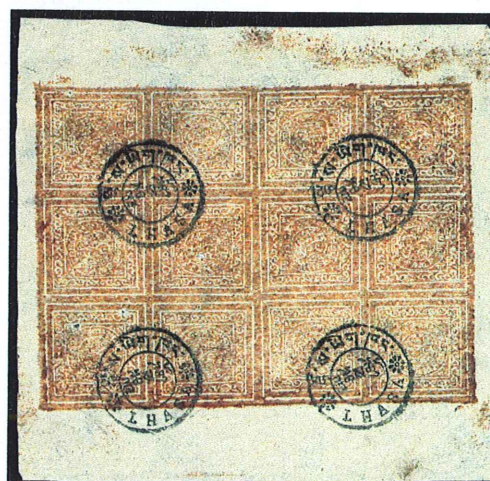




The postal validity of the "Official" stamps is in question, but this is a 'genuine' complete sheet of Scott #03 and the CTO LHASA Type VIII cancels are also genuine.



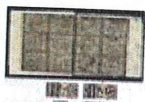
