Institution of 6^d Delivery Fee on parcels not liable to Customs Duty received from any place outside I. F. State for delivery within the State. Exceptions were parcels addressed to a Government Department: a parcel returning an exported article to the factory from which it had been exported: a parcel returning to the original sender an empty receptacle previously forwarded containing Eggs.

It became the practice of some dishonest postmen to cut off the reference to Postage - due labels, and retain the charge for their own benefit as is instanced by this mutilated Delivery Fee label:-

It would appear from the red-ink endorsements on the labels
("Royal" and "Orcesada") with date added, and the removal of the reference
to "Postage - due Labels", that some system of recording the payment of the
fees was instituted to prevent misappropriation by a small number of
dishonest postmen.

"DELIVERY FEE" Labels.

A Tax of 6 pence was practised for a relatively short period for the delivery of parcels.

A Postage Due stamp was to be affixed and cancelled on receipt of the amount collected, but this became neglected in a short time by dishonest operatives, and the system was abandoned in a relatively short period.
